<u>Third-Party Payments</u>	If your union or employer-sponsored Education Fund is covering your tuition, please submit a valid voucher or letter of credit to Bursar@slu.cuny.edu . Students remain responsible for any portion of tuition and fees not covered by the third-party payer.
<u>Tuition Partner</u>	Students enrolled with a Tuition Partner may qualify for free/reduced tuition. For more information, visit our website or contact your certifying official.
<u>Financial Aid</u>	Federal or State Aid and Loans require a Free Application for Federal Student Aid (FAFSA) . For more information or assistance, please contact FinancialAid@slu.cuny.edu . Please note, some SLU Scholarships also require a FAFSA!
<u>SLU Scholarships</u>	SLU Scholarships appear on your tuition statement as pending ("anticipated aid") by the Data Transfer date and typically disburse within 30 days of the Authorization date . If paying before the Data Transfer Date, you may view your award in Scholarship Manager and subtract that amount from your total due. Students are responsible for any balance not covered by their scholarship.
